Presentations made at meeting

The secretariat will send presentations to all project partners by the end of June 2005.

Website

Peter and Antonella will have meeting with ENSP to discuss the website during the summer 2005, and will prepare a draft plan, content and timetable by autumn 2005.

Country reports

A model country report will be drafted by Italy by the end of August 2005. Draft country reports based on the WHO profiles etc and the assessment tool will be prepared by the country partners by the end of October 2005 to discuss at the December 2005 meeting.

Country based meetings

Two country based meetings should be held by the end of January 2006.

Best practice report

The best practice report should be drafted by Peter Anderson by the end of October to discuss at the December 2005 meeting.

Assessment tools

The assessment tools should be analyzed by the end of August 2005, with a report drafted by the end of October 2005, for discussion at the December meeting. A draft paper for publication should be prepared by the end of November 2005.

2006 conference

The date and location of the conference should be confirmed once a decision on the 3rd year EC grant is known. A scope and purpose (why, where, when, what, how for whom and by whom), a draft budget and conference registration fee, and a preliminary programme should be prepared by the end of September 2005.

Fourth meeting

The fourth meeting will take place in Istanbul, 1-2 December 2005.
